

FACTS**WHAT DOES Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <input type="radio"/> Social Security number and Income <input type="radio"/> Account balances and Payment history <input type="radio"/> Overdraft history and Wire transfer Instruction
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce chooses to share; and whether you can limit this sharing.

What we do

How does Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We restrict access to nonpublic information about you to those employees who need to know the information to provide products and services

How does Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce collect my personal information?

We collect your personal information, for example, when you

- Open an account or Apply for a loan
- Show your driver's license or Make a wire transfer
- Provide account information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

-Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce *do not share with our affiliates which includes Bank of Commerce Holdings.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

-Nonaffiliates we share with can include BOC Wealth Management.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

-Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce *do not jointly market.*

Other important information

Redding Bank of Commerce and Sacramento Bank of Commerce, a division of Redding Bank of Commerce, comply with the California Financial Information Privacy Act and California's related opt-in/opt-out requirements. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products or services.

IMPORTANT PRIVACY CHOICES FOR CONSUMERS

You have the right to control whether we share some of your personal information.

YOUR RIGHTS

You have the following rights to restrict the sharing of personal and financial information with our affiliates (companies we own or control) and outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products or services.

YOUR CHOICES

Restrict Information Sharing With Companies We Own or Control (Affiliates):

Restrict Information Sharing With Other Companies We Do Business With To Provide Financial Products And Services:
